The Housing Authority of the City of Sheboygan requests proposals for an audit of the Authority's Project WIS47-1, WIS 47-2, Park Plaza, WISV047, Capital Fund Program and General Fund as prescribed by the U.S. Department of Housing and Urban Development (HUD). These projects include low income housing (135 units), capital grant, housing choice vouchers, project-based vouchers (105) and a non-federally assisted project (80 units). There is one additional property, WHEDA 038 with 48 units. We are asking for a three-year contract.

We are asking for a three-year contract bid for the years ending December 31, 2024, 2025 & 2026. Our year-end books are typically reconciled in February and the fieldwork needs to be completed by May. Hawkins Ash CPAs, LLP performs the Unaudited FDS. SHA Federal Awards expended in the past year \$1,657,486. The audit needs to be completed in accordance with Uniform Guidance. The Authority has no modernization funds and receives no PFS funding.

The audit shall be done in a manner acceptable to HUD and must be done in compliance with current HUD requirements. This audit must be done in a manner that meets the requirements of various GASB statements. Bidders should be familiar with all the audit procedures of HUD handbook(s) and HUD notices and provide an audit report that meets those requirements. The Housing Authority is depreciating property. Only certified public accountants licensed to practice in Wisconsin are acceptable.

Six paper and one electronic copy of the audit report will be required.

Bids should be presented on a total cost basis on the enclosed bid form. All bids should be delivered to the Authority in a sealed envelope clearly marked "AUDIT BID". All bids will be opened at the office of the Authority, 611 North Water Street, Sheboygan, WI 53081 at 11:30am on Monday, April 14, 2025. No bids will be accepted after that time.
